BOARD OF DIRECTORS MEETING October 18, 2021

Meeting Location - Club SRP Farmland

Board meeting was called to order by Jerry Geiger at 6:05 pm. The invocation and Pledge of Allegiance was led by Jerry Geiger.

ROLL CALL: Members Present: Jerry Geiger, Mark Sion, Ed Savage, Tim Brain, Jason Muller, Lyle Clark and Sarah Geiger

MINUTES OF September 20, 2021 MEETING: Mark moved to approve the minutes as emailed to the board and posted to the club website. Seconded by Ed. Motion carried.

TREASURER'S REPORT: Treasurer's Report was presented by Tim. Expenses paid for the club this past month included upcoming shows advertising in national magazines (\$247.50), spring kick-off meeting meal expenses (\$535.77) and club telephone (\$19.99). We deposited \$75.00 from membership renewals. We also had some hay sales deposits for \$700.00.

Wild Apricot – membership software is up for renewal on 11/15 for \$1188.00 for the year. Discussion was had on whether or not it makes sense to renew with them or look at a lower cost alternative that still provides the same features that we use. Sarah and Tim are going to research some options and report back at the next meeting on some options to consider. It was approved by the board to do a month-to-month renewal at \$110/mo for the next two months while some research is done.

The main checking account balance is \$41,518.51.

The savings account balance is \$63,727.13.

The Case account balance is \$10,185.55.

Motion made by Ed to accept the Treasurer's Report. Seconded by Mark. Motion carried.

OLD BUSINESS AND STANDING COMMITTEE REPORTS:

FARMLAND: Ed reported that the plow day was successful on Sunday, October 17th at the farm. Quite a few members came out to plow and turn over some dirt. Borders were pulled up also at the plow day. Manure is being spread on Friday, October 22nd on the east field and will be disced in to prepare the field for the U of A study that is being done.

There are no costs to the club for the U of A study other than our normal watering and laser work to prepare the field after the plow day which are expenses that the club would normally would have. The U of A will be providing the costs for the seed and any materials associated with the study. There was talk of doing a study on our existing alfalfa stand, but that is being postponed. The study will occur only in the East field in the middle and southern borders. Ed is deciding if he wants to do a parallel study in the norther border of the East field of our own. More details to follow.

Jason Muller resigned from the Farmland management team. With his upcoming workload and personal commitments, he doesn't have the extra time to commit to helping at the farm. This past month a team of club members have stepped up and will help Ed with the farmland activities. Moving forward, please contact Ed directly for any and all farmland questions for watering, alfalfa bale sales, plow days etc...

No update from the Northern Borders group on their Northeast border project. Jerry is going to reach out to either Red or Randy for an update since they have not been present at a board meeting in some time with what is going on with their Northeast border. They have been instructed to notify the club membership of any activity that they are doing with the border but since they have taken over the border, there has not been one notification sent out. This is supposed to be a club collaboration effort, like the other aspects of the farm and everyone is to be included. Jerry will report back at next board meeting on what is going on with that border and the future use of the border.
